ORDER

Provisional affiliation was granted to the B.Ed degree programme with 100 seats at C.K.Raghavan Memorial College of Teacher Education (Unaided), Kalanadikolly PO, Pulpally, Wayanad from the academic year 2004-05 with permission to start classes during 2005-06 as per the U.O read as first.

2. As per the reference read as 2nd, the NCTE has granted recognition to C K Raghavan Memorial College of Teacher Education (Unaided), Kalanadikolly post, Pulpally Wayanad for conducting the B.Ed programme of two year duration with one basic unit of 50 students from the academic year 2015-16.

3.Continuation of Provisional Affiliation was sanctioned to the B.Ed programme for the academic year 2017-18, vide the U O read as 3rd above.

4.As per the U O read as 4th, the Syndicate has resolved to grant Continuation of Provisional Affiliation to the Teacher Education colleges during the academic year 2017-18.

5.The Principal has applied for the Continuation of Provisional Affiliation to the B Ed degree programme for the academic year 2018-19 as per the paper read as 5th, remitting ₹ 1,31,000 as per chalan No.181056123 dated 29.01.2017 towards Administration fee,Affiliation fee and fine.

6. Considering the above, Sanction has been accorded by the Vice Chancellor on 22.03.2018 for the Continuation of Provisional Affiliation to the B.Ed degree programme with the following optional subjects and intake for the academic year 2018-19 at C K Raghavan Memorial College of Teacher Education (Unaided), Kalanadikolly (PO), Pulpally, Wayanad (Dt). The continuation of provisional affiliation granted shall be subject to the condition that the management should abide by the provisions of the University Act, Statutes and Regulations of the University with regard to admission of students, collection of fee etc.

7. Selection and admission shall be made only on the basis of the Rules and Regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

8. In the light of the direction of the Hon'ble Supreme Court of India in W P(C)656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.

9. As per the U.O.No. 5869/2015/Admn dated 09.06.2015 the conduct of University Examinations of any sort, including that of S.D.E examinations, is compulsory and binding on all colleges affiliated to the University of Calicut.

10. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for the continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University along with a copy of the letter of extension of approval from the NCTE.

11. As per the U.O.No. 12977/2015/Admn dated 22.12.2015 and U.O Note No. 27742/CDC-A3/2014/CU dated 25.1.2016 a list of colleges, which have renewed their provisional affiliation or applied for Continuation of provisional affiliation shall be forwarded to the Office of the Controller of Examinations every year to see that examinations are not conducted in those colleges which

have not applied for the Continuation of Provisional Affiliation and the same should be communicated to the colleges.

12. Admission to the next academic year shall be made only after obtaining prior permission from the University.
