WHEREAS, the recognition was granted to the Institution namely **C.K. Raghwan Memorial College of Teacher Education, Kalanadikolly P.O. Pulappally, Wayanad District, Pin-673579, Kerala** vide SRC (NCTE) order No. F.KL/SEC/N/149/SRO/NCTE/2004-2005/767 dt. 23.02.2005 for conducting **Secondary course** of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the Institution consented to come under new Regulations vide a notarized affidavit dated **22.01.2015**. a Revised Provisional Recognition Order (RPRO) was issued to the institution on **27.05.2015** for conducting **B.Ed.** Programme of two years duration with an annual intake of 100 students (**two basic units**) from the academic session **2015-2016**.

3. AND WHEREAS, the Institution has submitted written representation requesting for reduction of strength from **2 units to 1 unit** in its B.Ed. course received on **22.06.2015**. A Corrigendum issued vide order No. **F.SRO/NCTE/APS00516/B.Ed./KL/2015/68414** dated **25.06.2015** permitting the institution to have **one basic unit of 50 students** from the academic session 2015-2016.

4. AND WHEREAS, the case of the institution for final consideration of RPRO compliance issued vide order no F. SRO/NCTE/APSO0516/B.Ed./KL/2015-16/65709 dated 27.05.2015 was placed before the SRC in its **395th** meeting held on 25th & 26th February, 2021 and Committee decided as follows:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

*On the perusal of the reply submitted by the Institution, the Committee decided that the continuation order be issued to the Institution **C.K. Raghwan Memorial College of Teacher Education, Kalanadikolly, S. No. 284/4/1, Ward No. XIII, Kalanadikolly, Pulpallay Grama Panchayat, Kerala Pin- 673579, Kerala** for B.Ed programme for 1 basic unit of 50 students"*

NOW THEREFORE, this SRC is decided to permit the institution i.e., **C.K. Raghwan Memorial College of Teacher Education, Kalanadikolly, S. No. 284/4/1, Ward No. XIII, Kalanadikolly, Pulpallay Grama Panchayat, Kerala Pin- 673579, Kerala** for continuation of recognition for B.Ed course for 1 basic unit of 50 students subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.



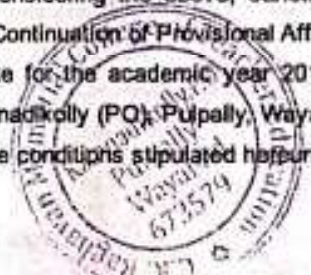
