The Placement Cell at C.K. Raghavan Memorial College of Teacher Education is a vital component of the Institution, functioning under the Internal Quality Assurance Cell (IQAC). It is dedicated to providing students with ample opportunities for professional growth. Established on 3rd July 2019, the Placement Cell has played a crucial role in guiding students towards successful careers, with a significant number of students securing placements over the last five years. Mrs. Sheena mol P.R appointed as Placement officer. The primary objectives of the Placement Cell are twofold: first, to provide training and placement opportunities to students, ensuring they are well-prepared for the job market; and second, to expose student teachers to the realities of the teaching profession across various levels, thereby offering valuable insights into their future careers. In addition to its core activities, the Placement Cell organizes career guidance classes and Kerala Teacher Eligibility Test (KTET) preparatory classes. Our KTET program, which began on 20th November 2011 in collaboration with DUCTUS Academy, has been instrumental in helping students prepare for the certification required to enter the teaching profession. 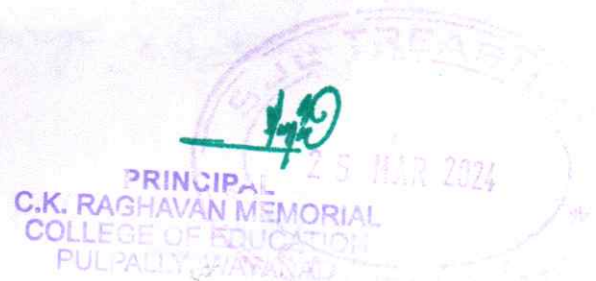

5. The lessee shall pay refundable, Interest free Security Deposit amount of Rs. 50,000/- (Rupees Fifty thousand Only) to the lessee and the amount shall be paid to the Lessor on or before 01-09-2024.

6. Duration:-

a) The Lessor hereby grants unto the lessee the First Floor for a period of Nine (09) years commenced from (01/06/2024) first day of June 2024 and expiring on 31st day of May 2033 (31-05-2033).

If both parties mutually agree for renewal of the period of lease the lessee shall issue 3 months notice in advance for request of renewal to the lessor and the lease can be renewed at such escalation rates in respect of rent as may be mutually agreed between the lessor and lessee prior to the expiration of the lease period.

b) Possession:-

i) The lessor had hand over vacant and peaceful possession of the scheduled Building on 01st day June 2024 (01-06-2024), upon executing the lease deed. The lessee shall be entitled to the vacant and peaceful possession of the scheduled building after the term of the lease.

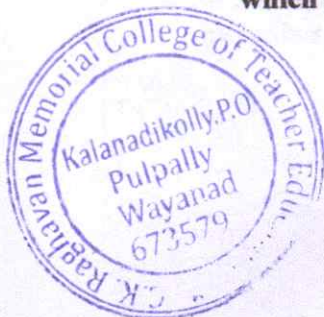
ii) From the exterior, which will bear, display the lessee's its business name, the lessee shall be liable to pay any charges for such name plates/logo etc that may be charged by any statutory authority in respect of the schedule rooms.

iii) The lessee shall attend to all minor repairs such as fuses, leakage of taps, replacement of consumable parts etc. at his own cost under intimation in writings to the lessor. However major structural, defects, repairs such as leakages of roof, walls, cracks in walls etc.. shall be promptly attend to by the lessor at his own cost, provided such repairs are not attributable to any act or default on the part of the lessee. If the lessor does not attend to such major repairs as pointed out by the lessee in writing within a period of 30 (thirty) days from the receipt of notice, then the lessee may get the repairs done and deduct the cost from the rent payable under this deed.

iv) The lessee shall regularly and punctually pay directly to the KSEB for the electricity consumed charges.

c) The lessee shall not sub-let, assign or otherwise part with possession or create any interest or whole or part of the schedule room to any 3rd party without the written consent of the lessor.

d) The lessee shall not carry out any acts or activities which are obnoxious, anti social, illegal or prejudicial to the norms of decency or which may cause nuisance or annoyance.
